

**CITY OF SIMPSONVILLE  
REGULAR CITY MEETING MINUTES  
CITY COMMISSION ROOM  
JUNE 3, 2008 7:00 PM**

Mayor Eden called the meeting to order at 7:00pm.

Pledge.

Mayor Eden presented the minutes from May 6, 2008 regular meeting for approval and everyone was furnished a copy. **Commissioner McDowell made the motion to accept the minutes as presented. Commissioner Shelburne seconded.** Motion carried unanimously.

Mayor Eden presented the minutes from the May 29, 2008 Public Hearing meeting for approval and everyone was furnished a copy. **Commissioner Vowels made a motion to accept the minutes as presented. Commissioner Shelburne seconded.** Motion carried unanimously.

Mayor Eden presented the minutes from the May 29, 2008 Special called meeting for approval and everyone was furnished a copy. **Commissioner McDowell made the motion to accept the minutes as presented. Commissioner Wise seconded.** Motion carried unanimously.

Mayor Eden presented the Effluent contract with the Cardinal Club for approval and everyone was furnished a copy. City Administrator Eaton explained the contract. **Commissioner Wise made the motion to authorize Mayor Eden sign the effluent contract as presented. Commissioner McDowell seconded.** Motion carried unanimously.

Mayor Eden recognized City Administrator Eaton: City Administrator Eaton advised the 2008/2009 lease agreement with Our Lady of Guadalupe is up for renewal which included a forty dollar increase per month due to inflation. **Commissioner Wise made the motion to authorize Mayor Eden to sign the 2008/2009 lease agreement. Commissioner Shelburne seconded.** Motion carried unanimously.

Mayor Eden presented an outline for a small area study to be done by Triple S Planning and Zoning which would create a small downtown district. **Commissioner Wise made the motion to authorize Mayor Eden to make the request to Triple S Planning and Zoning to proceed with the study. Commissioner Vowels seconded.** Motion carried unanimously.

Mayor Eden recognized the City Attorney's Report: City Attorney Hays had nothing at this time.

Mayor Eden recognized the City Administrator's Report: City Administrator Eaton advised an agreement has been reached with The Lincoln Foundation to provide sewer service. City Administrator Eaton advised Attorney Brammell is drafting the final contract. **Commissioner McDowell made the motion to authorize Mayor Eden to sign the contract between the City and Lincoln Foundation. Commissioner Vowels seconded.** Motion carried unanimously.

Mayor Eden recognized the Police Department's Report: Police Chief Chappell had nothing at this time.

Mayor Eden recognized the Park's Department Report: Absent.

Mayor Eden recognized the City Clerk's Report: City Clerk Batliner had nothing at this time.
