REGULAR CITY MEETING MINUTES

JUNE 1, 2010 7:00 PM**

Mayor Eden presented Ordinance #2010-007 pertaining to the 2010-2011 Budget for second reading and possible adoption and everyone was furnished a copy. City Administrator Eaton read Ordinance #2010-007. **Commissioner Vowels made the motion to accept the second reading and adoption of Ordinance #2010-007 pertaining to the 2010-2011 Budget. Mayor Eden advised that the City was recently recognized by the American Planning Association Kentucky Chapter at their annual conference for the Village Center Project.

Mayor Eden recognized the Commissioner's Report:

**Commissioner McDowell** had nothing at this time.

Commissioner Wise seconded.** Motion carried unanimously.

Mayor Eden recognized the Police Department's Report: Police Chief Chappell had nothing at this time.

Mayor Eden recognized the Parks Department's Report: Commissioner Vowels advised the softball and baseball leagues have started.

Mayor Eden recognized the City Clerks Report: City Clerk Batliner advised the KLC Safety Grant has been completed and submitted for reimbursement.

Mayor Eden recognized Mrs. Shinabery. Mrs. Shinabery shared concerns about the Rolling Ridge HOA. Attorney Hays advised Mrs. Shinabery that the City doesn't regulate the Home Owner Associations, and she would need to seek legal advice on her own to address her concerns.
