

**CITY OF SIMPSONVILLE
REGULAR CITY MEETING MINUTES
CITY COMMISSION ROOM
NOVEMBER 4, 2008 7:00 PM**

Present: Mayor Eden, Commissioners McDowell, Vowels, and Wise. City Attorney Hays was in attendance as legal council, City Administrator Eaton, and Police Chief Chappell. Guests: Nathan McBroom/Sentinel News, Patrick Luken, and Justin Luken.

Mayor Eden called the meeting to order at 7:00 pm.

Pledge.

Mayor Eden presented the minutes from October 7, 2008 regular City meeting for approval and everyone was furnished a copy. **Commissioner Wise made the motion to accept the minutes as presented. Commissioner McDowell seconded. Motion carried unanimously.**

Mayor Eden presented Resolution #2008-004 pertaining to Ordinance #2000-001 for approval and everyone was furnished a copy. City Attorney Hays read Resolution #2008-004. **Commissioner McDowell made the motion to accept Resolution #2008-004 pertaining to Ordinance #2000-001. Commissioner Vowels seconded.** Motion carried unanimously.
